Sub : Issue "**No Objection Certificate**" in favour of G.D. Goenka Public School, Dhukuria, P.O. New Champta, Dist. Darjeeling, Siliguri - 734 009 for 2 years starting from 2011-12 academic session.

The State Government in the School Education Department hereby issues a provisional "No Objection Certificate" to the Secondary wing of **G.D. Goenka Public School**, Dhukuria, P.O. New Champta, Dist. Darjeeling, Siliguri - 734 009 for the purpose of preparing its candidates to appear in the final examinations of the Central Board of Secondary Education, under the following terms and conditions :-

1. That the school authority shall never claim any financial assistance from the State Government.
2. That the school authority shall implement the prescribed pay scales and allowances for the teaching and non-teaching staff of the school.
3. That the school authority shall provide retirement benefits to the teaching and non-teaching staff of the school as per a Death Cum Retirement Benefit Scheme.
4. That the managing committee of the school shall be constituted with at least three members, three elected teacher members and one non-teaching staff.
5. That the school authority shall not enhance tuition fees or charges without prior permission of the competent authority.
6. That the school shall not charge any capitation fee or anything equivalent to capitation fee by any means.
7. That the recruitment of teachers shall be done in accordance with transparent, merit-based criteria to be laid down in the Memorandum of the Parent Body and information thereof shall be made available to the State Government, if necessary.
8. That the funds raised, the fees collected and income from any other source earned by the school authority, shall not be utilized for any other purpose than the welfare of the school and benefit of education of the students and the teaching and non-teaching staff of the school.
9. That no change in the ownership of the school or handing over of property or management of the school in any manner or changing / amending the character of the Parent Body shall be done without prior notice to the State Government.

10. That service of no teaching and non-teaching staff shall be terminated without giving opportunity of being heard by the competent authority and without observing the disciplinary proceedings.
11. That the service conditions of the teaching and non-teaching staff including provisions of security of service, disciplinary proceedings and procedure for Appeal shall be implemented in accordance with the directions laid down in the Memorandum of the Parent Body and submitted to the State Government.
12. The school shall abide by procedures and rules and legal provisions that may be promulgated in this regard.
13. The school will pay its teaching and non-teaching staff emoluments at a rate which should not be less than those of their counterparts with equivalent educational qualifications.
14. The school will provide for Contributory Provident Fund for the employees as prescribed under the relevant Provident Fund Act/Rules of the Govt. of India.
15. 10% (ten percent) of the new admissions in the school in each academic year will be allowed on the recommendation of the School Education Department and 50% of such students will have to be allowed to prosecute studies in the school free of any cost.
16. The School shall have to furnish accurate and up-to-date statistical information relating to the functioning of the school and its academic activities as and when the same is called for by the Deputy Director of School Education (AIS), W.B.
17. Violation of any of the conditions laid down in sub-para (2) to (16) above shall entail withdrawal of the "No Objection" of the State Govt. with effect from the beginning of the academic year next to that in which the violation is committed.
18. The school shall meet up the deficiencies mentioned in this Deptt.'s Memo No.1057-SE(S)/6C-38/2010 dt. 14.09.2011 within 6(six) months under intimation to this Deptt.
